#### **Prizes / Awards:**

• Cash prize, each division: 1st Place \$100; 2nd Place \$50; 3rd Place \$25

• Special Certificate Award – Judge's Award for Best of Show

• Exhibition Award – All award winners will be invited to participate in a group show at Sanchez Art Center in 2026.

**Entry Form**: Entries must be accompanied by a \$10 entry fee and the Pacific Coast Fog Fest Photo Contest Entry Form.

Up to 2 entries will be accepted per entrant. The fee is \$10 per entrant (not per entry).

Checks should be made payable to: FFOG

**Size Requirements:** Entries may be no larger than 12" x 14" including the frame. If your frame is ½" or more larger than these dimensions, they will not be eligible and will not be displayed. The display area is limited, so we must adhere to this requirement. Caution: Size is calculated on the total piece. Don't buy your frame based on the size of the mat! Look at the total dimensions of the entire frame!

#### **Framing Requirements:**

• Photos must be protected by acrylic or glass. No raw glass edges allowed.

- No entries will be returned via mail.
- Entries not picked up by Oct 3 will be disposed of at the discretion of Sanchez Art Center.
