Work must be able to fit through a standard-sized door (80" x 36"). <u>All 2D work must be framed and wired</u> (no sawtooth hangers). Other display methods are subject to the approval of the Art Center.

#### **ENTRY FEE**

There is no limit on the number of artworks an artist may enter. The fee for each artwork entered is \$15 (i.e., the fee is \$30 for 2 artworks, \$45 for 3, etc.). Entry fees are not refundable. Make checks payable to Sanchez Art Center. Visa and Mastercard are accepted.

#### SALES

Sales are encouraged. SAC retains a 30% commission on any works sold. Artists should include the 30% commission in the sales price. Sales tax will be administered by SAC.

#### RETURNS

Slides or CDs sent without a self-addressed, stamped envelope will not be returned. Entries without fees included will not be juried. Shipped work must be sent with a prepaid return shipping label, or it will not be accepted.


#### LIABILITY
